## **GENERAL INFORMATION AND FUN TEST RULES**

### **REGISTRATION:**

Open: Sunday November 3, 2024 at 8 pm – Thursday December 5<sup>th</sup>  
at 5:00 pm or when the Fun Test is full.

Instinct: \$20.00 Novice: \$32.00 Open: \$32.00 Senior: \$32.00

Masters: \$32.00

**Entries are FINAL – there will be no refunds for missed/pulled entries for the Fun Test.**

**SCHEDULE:**

**Check in:** Secretary Desk inside main front double doors of horse barn – please check in without your dog due to space constraints. Opens at 7:45 am until 8:30 am.

**General Briefing:** Approximately 8:10 am.

**Classes Offered & Tentative Running Order:**

Sunday Fun Test 1 and Fun Test 2 will run concurrently.

Master, Master, Senior, Senior, Open, Open, Instinct, Novice, Novice

There will be no move ups.

‘B’ CLASSES: Offered. If you have a RATM title then you are working toward RATCH and MUST be in the B Class (Championship).

Each day: Small to Tall with accommodations made for handlers with multiple dogs. Judge will break for lunch at their own discretion.

**Dogs are required to have a Barn Hunt Registration number to enter the Barn Hunt Fun Test. Register your dog online at : [www.barnhunt.com](http://www.barnhunt.com)**

Dogs may enter both the Instinct class and Novice class in the same Fun Test until the dog has earned the RATN title and then they can't enter the Instinct class.

**CONFIRMATION OF ENTRY:** The receipt of entries will be confirmed once your runs have been approved for those providing a return e-mail address on their form. Confirmations are sent via email. If you don't receive an email confirmation before the closing date email the Trial Secretary ASAP!

**VALIDATION OF ENTRIES:** Entries must be complete, accurate and legible with entry fees, signed WAIVER AND INDEMNITY included. Entries submitted without this agreement filled in and signed will be refused participation in the Fun Tests.

**AWARDS:** Qualifying Fun Test runs will be awarded a prize.

**FUN TEST SITE:** The Fun Test will be held indoors in an indoor horse arena. The arena is NOT heated so please dress accordingly. A Port-a-Potty will be on site – it is not wheelchair accessible. Bring water, shelter, etc. for you and your dogs (crate, x-pen). Fun Tests will run rain, shine, snow.

**PARKING:** There is a lot of parking in the gravel lot beside the indoor horse arena.

**BITCHES IN SEASON (BIS):** May run in Barn Hunt trials and fun tests, but MUST wear panties. You MUST inform the Trial Secretary prior to the Fun Test and inform all exhibitors at the judge's briefing that you are bringing a BIS. Failure to do so is grounds for disqualification and dismissal. Owners of BIS will crate/confine their dogs in the Club's separate designated area for BIS and will only walk and potty their dog in that designated area.

**NOTICE TO EXHIBITORS**

- All dogs **must be under control & on a short leash** while on grounds, except when competing in the ring.

- Use approved BHA collars. Dogs MUST run “naked” in the ring. PRONGS are allowed with quick detach and COVERED. See BHA rules for specifics.
- Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or person may be dismissed from the Fun Test and the grounds if justification is found to do so by the judge and/or Trial Committee. In such case, no refund of any fees paid will be made.
- Loud/Disruptive dogs: Please keep barking to a minimum so as not to disturb working dogs and/or people who live on the property.
- Exhibitors are responsible for being ready to go to the blind area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class/blind.
- Exhibitors and spectators are required to respect all signs posted on the property.
- Handlers MUST clean up after their dogs. There will be baggies available and a garbage bin for disposal.
- Please stay away from both homes on the property and from the horses/horse paddocks. This Fun Test is being held on private property and we are here at the pleasure of our hosts.
- Children need to be under strict supervision at all times. Out of respect for our competitors, if their behaviour is disruptive you will be asked to leave the property.
- The B-RAT Pack Club and Iverstone Equestrian Park will use care and diligence for the safety and welfare of the dogs, the exhibitors, the spectators and the quarry, but will not be responsible in the event of any accident to dogs, exhibitors, spectators or quarry.
- **There is NO SMOKING on the grounds anywhere.** The use of illegal drugs and/or alcohol and or smoking/vaping of any kind including legal marihuana will NOT be permitted at the

Barn Hunt events held at Iverstone Equestrian Park. This includes within your vehicle while on the grounds. You will be excused immediately from the grounds without refund.

- No flexi leashes are permitted anywhere on the property.
