Move-Ups

Forms will be available at the Secretary's table. Previous trial move-ups must be submitted no later than Wed March 5th, at 5:00 pm MST via email to the Trial Secretary. Same day move-ups must be submitted no later than 30 minutes prior to the start of the trial you choose to move-up into. Next day move-ups must be submitted to the Trial Secretary no later than 30 minutes before the end of trials on the original day.

Dogs may move UP (A stream) or DOWN (B stream) once completing a title.

Dogs may choose to Move DOWN to a B stream class for the next trial day if there is room/at secretaries' discretion.

- Facility is handicapped/wheelchair accessible. Please contact us prior to the event so we can arrange appropriate accommodations.
- Indoor benching is NOT available.

Rings

The ring is enclosed with 24' x 24' snow fencing braced with wooden frames on 4 sides.

Blinds

One indoor blind is 10' x 20' room at the front of the building

5 dogs will be loaded in the blind for higher levels. 6 dogs will be loaded in the blind for Instinct Novice and Open.

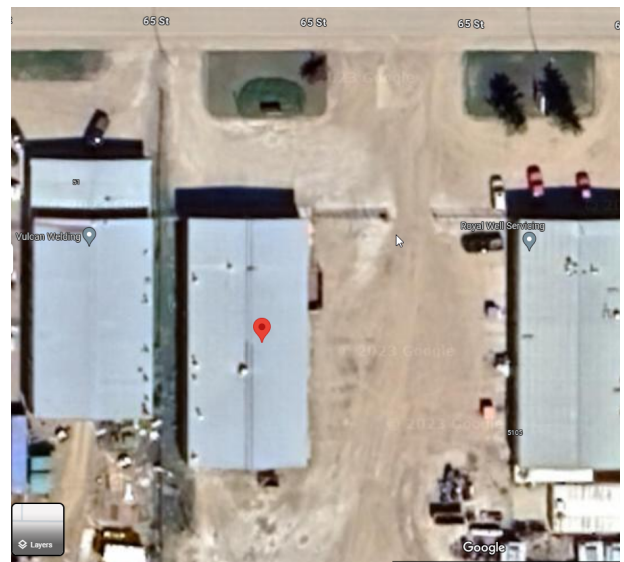
Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event

Awards

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th in each height division for all classes except Instinct. New title ribbons and High in Class ribbons will also be awarded. Ribbon tabs will be provided for all new titles. B Classes will receive 1st through 4th, with one HIC for all height divisions combined. Master B placements will be awarded 1st to 4th in each height class and a HIC overall. Crazy 8 Title ribbons will also be awarded.

Grounds

Barn Hunt grounds include the parking lot, the reception area, the blind, and area directly surrounding the ring.



Parking

Parking in the Main front parking lot, the side lot can be opened if necessary as well please let staff know.

On weekends, parking in our neighbours lot (Royal Well Servicing) will likely be open as well as street parking.

Mail in Entry Form

Please contact the Trial Secretary for the address if mail-in entry is desired. Entries must be received by the closing date in order to be considered. You may email this form as well.

Withdrawal & Refund Policy

- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials prior to the closing date will receive a refund of all entry fees, minus any non-refundable credit card/Dogshow transaction fees, if applicable.
- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials after the closing date are not eligible for a refund.
- The only exception is if runs are filled from the waitlist and then a refund will be issued (minus any non-refundable fees).
- Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid minus any non-refundable credit card/Dogshow transaction fees, if applicable, upon receipt of a note from your veterinarian. The note must be dated and emailed to the Trial Secretary prior to the close of the trial. If you have questions, contact the Trial Secretary directly at info@culturedcanines.ca
- Entry fee(s) will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.
- Entry fee(s) will not be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee.
